

## *DeKalb County Airport Advisory Board (AAB) Minutes*

The DeKalb County Airport Advisory Board met on Monday, April 11<sup>th</sup>, 2022 at 5:30 PM via Zoom Video Conference call.

Members Present: Doug Miller (AAB Chair), Larry Scheinpflug (Vice Chair), Reuben Jones, Mike Reeves, Doug Miller, and Christopher Richard

Others Present: Airport Director Mario Evans, Deputy Airport Director Hunter Hines, and Noise and Environmental Analyst Korey Barnes

The meeting was called to order at 5:32p.m. by AAB Chair, Doug Miller.

- I. Approval of Minutes: **Motion to approve the March 2022 minutes was made by Larry Scheinpflug and seconded by Chris Richard.**
  
- II. Information/Old Business
  - A. **Airport Director's Report (Mario Evans):**
    1. Airport Master Plan: Evans stated that Master Plan is still with Board of Commissioners for approval. Waiting for them to put it on the agenda for approval.
    2. Good Neighbor Day Airshow: Airshow will be May 14<sup>th</sup>. Hope everyone comes out for a fun festive time! Celebrating the 80<sup>th</sup> anniversary.
    3. Minimum Standards: Hunter Hines reported that draft is being finalized and will be sent to committee to review, make comments.
      - Douglas Miller asked Hunter to describe Minimum Standards for benefits of those on call.
      - Larry Scheinpflug asked to have pointed out where this is listed on website. Evans answered: On the pdkairport.org website under the "What's New Tab".
      - Reuben Jones asked if committee reviewing is assembled from a broad spectrum of airport users: Hines answered: Yes.

**Noise and Environmental Analyst Report:** - N&E Analyst, Korey Barnes delivered the following report:

**The March 2022 Noise Report** will be posted on the website in its entirety: **Total operations were 15,327** which is an increase of 19.25% as compared to March of 2021. There were 385 voluntary curfew operations. Total 2022 year-to-date operations are **43,208** as compared to the total 2021 operations as of March 2021 of 32,617. In March 69% of operations were on a southerly flow, 28% were to the north, and 3% were on the NW/SE runway. **Noise complaints:** 22.6 households made 859 complaints. The majority of the complaints were made between 12:00 PM and 05.59 PM. (35%). The Complaint Percentages by Zip Code chart shows that 69% of the complaints originated from the **30360** zip code. A total of 175 advisory letters were sent to aircraft operators who flew during the Voluntary Curfew Period who were not identified as MedEvac and/or other emergency flights. Regarding High Noise Events, 46 advisory letters were sent to the operators whose aircraft exceeded the high noise event threshold(s).

- Jordan Fox helped with airshow website. Decision was made to transition all data to PDK website. Information will be on a separate tab for the airshow.
- Jordan Fox initiated discussion about what constitutes a new complainant.

**Motion to accept the March 2022 Noise Reports were made by Larry Scheinpflug and seconded by Reuben Jones. Motion passed.**

- B. **Other:**
  - Scheinpflug asked Hines about the Minimum Standards statement regarding all FBOs requiring a

wash basin. Evans answered: these Minimums will be enforceable for all FBOs. Evans also explained changes in regulations regarding washing aircraft.
