For questions and requests for interpretation after the pre-bid conference, each response shall be given in written addendum, separately numbered and dated, and published on the County website in sufficient time for interested parties to review. **No requests for interpretation, answers to scope or specification questions, contract exceptions, or additional information shall be accepted after Monday, August 22, 2022, at 5:00 P.M. EST.**

2. ITB 22-101488, INSTRUCTIONS TO BIDDERS, FEDERAL WORK AUTHORIZATION PROGRAM PARTICIPATION. Delete in its entirety and replace with the following:

All qualifying Contractors and Subcontractors performing work with DeKalb County, Georgia must register and participate in the federal work authorization program to verify the work eligibility information of new employees. Bidders will submit the Affidavit of Compliance with O.C.G.A. §13-10-91.
