A) Polling Place Changes

Ms. Hamilton explained that the Chamblee; Doraville North & South, Memorial South, and Stonecrest polling place locations will no longer be able to accommodate the department on Election Day. Thus, Ms. Hamilton is proposing the following changes:

- Chamblee will move to Chamblee Public Safety/Municipal Court at 4445 Buford Hwy NE, Chamblee, GA 30341
- Doraville North & South will move to Doraville Civic Center at 3770 Central Ave., Doraville, GA 30340
- Memorial South will move to Georgia Piedmont Technical College at 495 N Indian Creek Dr., Clarkston, GA 30021
- Stonecrest will move to Stonecrest Library at 3123 Klondike Rd., Stonecrest, GA 30038

Ms. Swift asked about the distance from the original polling places to the proposed locations, why the original locations could no longer accommodate us, and if there is a communication plan. Ms. Hamilton stated that the proposed polling places are all within the precinct boundary lines and a notice regarding the change in polling place will be mailed as required by law.

Ms. Motter asked if the legal notice was posted in *The Champion*. Ms. Hamilton confirmed that the notice for today's special called meeting and proposed polling place changes were published in *The Champion* on Thursday, August 26, 2021 and Thursday, September 2, 2021.

Motion by Ms. Smith and seconded by Ms. Jester to approve the proposed polling place changes. Motion carries by unanimous vote.
