RE: 230 Voter Challenge to Inactive Voters Furnished with an Absentee Ballot

Dear DeKalb Board and Director Smith:

Under OCGA 21-2-230, this letter formally serves as my **challenge to the right of the electors listed on the attached spreadsheet to vote in the 2022 midterm election.**

On the DeKalb voter roll of 10/3/2022 from the Georgia Secretary of State, these individuals are listed as **inactive status voters**. Per OCGA 21-2-235, an inactive voter can only be returned to active status by signing a written petition affirming the voter's valid address. **The code section also makes clear that this signature is only satisfactory "if valid".**

**The only other way** a voter can restore active status is by voting **in person** "at the polling place of such elector's last address" (OCGA 21-2-235). They also would need to affirm in writing their valid address at that time (OCGA 21-2-235). This is clearly not relevant to the current case, where the voter was simply mailed a ballot.

A voter cannot be returned to active voting status **simply because an absentee ballot is requested under their name**. Current Georgia law does not call for absentee ballot application signatures to be verified as valid (there just needs to be some sort of signature filled in – see OCGA 21-2-381(b)(1)). SB 202 changed the process to validation by driver's license number. **Nor is there a signature match requirement for validating the absentee ballot itself** (see OCGA 21-2-386(a)(1)). **Thus, the valid signature match required to restore active status (see OCGA 21-2-235) was not satisfied.**

To make this even more clear cut, Section (c) of 21-2-235, which sets out the circumstances in which an inactive status voter **may** be allowed to vote. Notably, in all three scenarios described, the voter **must come vote in person** at the polling place of their last address. **Nowhere does it allow for an inactive voter to vote by mail-in ballot.** This also aligns with common sense – the inactive voter list is Georgia's process for systematically removing ineligible voters from our rolls. We would expect a somewhat higher hurdle for inactive voters to cast a vote.

In sum, it appears these voters should never have been mailed an absentee ballot at all. Thus, I am **not** bringing a challenge to remove this voter from the rolls entirely. Section 230 also provides for challenges that are **"based on grounds other than the qualifications of the elector to remain on the list of electors"**, which is what I'm submitting. There is no requirement that successful 230 challenges of this sort result in the voter being removed from the rolls.

As my challenge is not petitioning for the voter's removal from the rolls, the National Voter Registration Act's notice requirements and language on "systematic removals" do not apply. **Instead, I am challenging solely the voter's right to vote in the 2022 midterm election, pending their ability to appear before the Board (in person or virtually) and validate that they should be returned to active status (and thus allowed to vote in our midterms).**

Alternatively, they could come to vote in person and affirm their residency as per OCGA 21-2-235.

As a registered voter in this county, I am within my rights to raise this challenge per Georgia Code 21-2-230. I affirm that everything in this letter is true to the best of my knowledge. DeKalb County elections has access to all documents pertaining to this voter – which I do not – and so I am open to any additional information they have which would explain this apparent issue.
